Certified Lighting Designer Privacy Notice

Updated April 2024

The Certified Lighting Designer (CLD) program takes its obligation seriously to protect the personal data that we collect, use, share, and process. This privacy notice tells you what to expect when you provide information to the CLD.

CLD Principles Regarding User Privacy and Data Protection

- We believe user privacy and data protection are basic and important rights
- We take protecting your privacy seriously, and it is our practice to protect the confidentiality of this information and to limit access to it to those with a business need.
- We will only collect and process data when it is necessary, and when we do, we will make it clear why we are doing so and how it will be used.
- We will not send you regular email newsletters that you have not subscribed to, and if subscribed, we will always give you the choice to unsubscribe.
- We will only share your personal information with contracted vendors necessary to accomplish the work of the CLD.

What type of information we have

We currently collect and process the following information:

- Personal identifiers, contact information (i.e., name, postal address, email address)
- Place of employment
- Category of IALD membership
- Credit card information to process payments

How and Why Information Is Gathered

Most of the personal information we process is provided directly by you for one of the following reasons:

- To become a Certified Lighting Designer
- To register for a CLD event (in-person or virtual)
- To promote oneself or your company in the CLD public directory

Third-Party Data Processors

The CLD may share elements of your data with third-party processors to further the IALD mission to advance the global lighting design profession through leadership and advocacy

and serve its members by promoting lighting design education, community, and engagement.

Processors we may share elements of your data with include:

- Payment gateway processors (i.e., PayPal LLC, J C Morgan Chase Bank) contracted to handle online payment transactions.
- Event management service providers (i.e., Cvent).
- Association Management Systems (i.e., ASI iMIS) contracted to facilitate CLD/IALD/IALD Education Trust functionality, including membership, event registration, digital communications, etc.

Website Analytics: Access and Usage Data

When someone visits the CLD website, we use a third-party service, Google Analytics, to collect standard internet logging information and details of visitor behavior. We may use this information to determine how many people visit different portions of the website, which resources direct that traffic, and how the site content is navigated. This analytic data helps us better tailor the user experience over time. The information is processed in a way that does not personally identify any site visitor. We do not make, nor do we allow Google to make, any attempt to find out the identities of those visiting our website. (To opt out of being tracked by Google Analytics across all websites, visit the Google Analytics Opt-Out Tool.

What are "Cookies"?

Cookies are alphanumeric identifiers that a website transfers to your desktop or mobile device through your web browser for record-keeping purposes. Our website requires persession cookies to provide log-in functionality, process payments, and manage registrations. With your permission, we may also be able to enable session cookies that improve site navigation, personalize your content, and allow us to track site activity for marketing purposes.

Pixel Tags and Related Technologies

Pixel Tags are graphics with a unique identifier that function similarly to cookies. However, while cookies are stored on your desktop or mobile device, these technologies are embedded invisibly on web pages. With your permission, we may use these technologies (clear GIFs, web beacons, web bugs, etc.) to improve user experience, personalize content, identify traffic sources, and analyze site usage. We may also use such tags in email communications to help track delivery success, open and click rates, message forwarding, and other behavior.

Site Search Engine

Our website search engine uses internal content indexing to provide results. No user-specific data is collected as part of this search.

iMIS/RISE

We use a third-party tool, RISE, provided by our contracted association management software, iMIS, to manage and host our website. iMIS collects information users provide to facilitate account and membership functionality, event management, digital communications, and processing payments for credentialing and memberships, and event registrations.

Users need to create an account on iald.org or cld.global to process event registrations or purchase items via online payment transactions, and the details of this account are stored in iMIS. All transactions are secure and encrypted via PayPal. Only anonymized transaction IDs are stored.

Email Communications

Our association management software (iMIS) facilitates automated email delivery from the CLD, using sender validation and spam-protection technologies through Twilio SendGrid. SendGrid gathers data on our behalf to help us monitor and improve the quality and deliverability of email communications. We only send messages to people who have opted in to receive communications from us. Individuals can opt out of receiving messages from us on any or all communications categories at any time by updating their account preferences on the CLD website.

Surveys

We use a third-party provider or software, SurveyMonkey to deliver our surveys from the CLD.

People Who Register for a CLD Event

We use a third-party provider or software, Cvent, to process your registration and collect payment for most IALD events. Cvent's privacy policy can be located here: https://www.cvent.com/en/cvent-global-privacy-policy

People Who Contact Us Via Social Media

We use a third-party provider, Hootsuite, to manage many of our social media interactions, along with the services innately provided by Facebook, Twitter, LinkedIn and Instagram. If you send us a private or direct message via social media, the message will be stored by Hootsuite (or the respective social media platform) for up to one year. The message will not be shared with any other organizations.

People Who Receive Physical Mail from the CLD

As the global architectural lighting design credentialing body, CLD communicates not only with its members but also with others in allied fields that use or touch on lighting design such as architects, building engineers, and non-member lighting designers, etc., assuming there is a legitimate interest in receiving this information. You may receive physical mail from the CLD providing information on advances in lighting, news about the IALD Education Trust, the IALD Education Trust Scholarships/Travel Stipends program, fundraising for the IALD Education Trust, details about the Certified Lighting Designer (CLD) credential, news about upcoming conferences and events, promotion of IALD's members, etc. You can opt out of receiving physical mail by updating the Preferences on your CLD.global profile or emailing info@cld.global.

Data Transfers

We may transfer to and store the data we collect about you in countries other than the country in which the data was originally collected, including the United States, and other destinations outside of the European Economic Area (EEA) and Brazil. These countries may not have the same data protection laws as the country in which you provided the data. In certain circumstances, courts, law enforcement agencies, regulatory agencies or security authorities in those other countries may be entitled to access your personal data. However, CLD will do its utmost to protect your personal data and comply with laws surrounding data transfer and data privacy.

EU and UK Citizens' Rights for Information

As a resident and/or citizen of an EU member state or the UK, you have the following rights for information under the General Data Protection Regulation (GDPR) (EU) 2016/679 and the UK GDPR:

- The right of access the right to review any personal data we hold on you
- The right to rectification the right to request corrections or updates to any personal data we hold on you without undue delay
- The right to erasure the right to have your data erased from our archives

- The right to restrict processing the right to clarify and specify how we may and may not use data we hold on you
- The right to data portability the right to receive data held on you in a commonly used and machine-readable format
- The right to object to data processing under certain circumstances at any time
- Rights in relation to automated decision making and profiling (IALD/IALD Education Trust do not use automated decision making or profiling)

Brazil Citizens' Rights for Information

Article 18 of the Brazilian General Data Protection Law (Lei Geral de Proteção de Dados Pessoais or LGPD) outlines that Brazilian citizens have the rights to:

- Confirm the existence of the processing of their data
- Access their data
- Correct incomplete, inaccurate, or out-of-date data
- Anonymize, block or delete unnecessary or excessive data or data that is not being processed in compliance with the LGPD
- Portability of data, i.e. handed over to another service or processor if requested
- Have their data deleted
- Information about public and private entities with which the controller has shared data
- Information about the possibility of denying consent and the consequences
- Revoke consent

How Do We Use Your Data?

Donor Privacy Information

The CLD will not sell, trade or share a member's/donor's personal information, including their name, phone number, email, or physical address with non-CLD third parties nor will it send donors mailings on behalf of other unrelated organizations. This policy applies to all information received by CLD, both online and offline, as well as any electronic, written or oral communication.

Credit Card Account Information

The CLD does not disclose credit card account information provided by its members and users. When users choose to pay using their credit cards, the CLD uses secure protocols to submit the information needed to obtain payment to the appropriate clearinghouse. All payment information is encrypted and secure. Please never send CLD—or anyone—your credit card information via email.

Disclosures to Third Parties

If you would like your accomplishment of achieving CLD recognized publicly, with your permission, the CLD may share your name, photo, company, and biography in various print and digital media formats including print publications, websites, e-marketing, posters, banners, advertising, film, and social media. If you grant this permission, you need to understand that this information is then available to the general public and the use of it is no longer in the control of the CLD.

Mailing Address

The CLD may share mailing addresses with third party mailing houses to process postage and deliver mail to people with a legitimate interest in the lighting industry and the services of the CLD, IALD and the IALD Education Trust, or who have requested to receive certain information. CLD only shares as much information as is required to fulfill the mailing, and mailing houses delete the information as soon as mailings have been distributed.

How Long We Retain Your Personal Data

The CLD retains personal data identifying you for as long as necessary in the circumstances— for instance, as long as hold an active CLD or have a relationship with the lighting industry, the CLD will for a reasonable period send you information where we have regular contact with you, or as may be needed to enforce or defend contract claims or as is required by applicable law.

The IALD and the IALD Education Trust have adopted a Record Retention and Destruction Policy which the CLD abides by (available on request). The criteria we use for determining the relevant retention and disposal periods we adopt are based on the purpose for which we hold data and the reasonable expectations of those whose personal data we collect in these circumstances, taking into account various legislative requirements and guidance issued by relevant EU regulatory authorities.

In accordance with the above retention policy, the personal data that we no longer need will be disposed of and/or anonymized so you can no longer be identified from it.

Links to Other Websites

This privacy notice does not cover the links within this site linking to other websites. When clicking on external links from the IALD website, please be aware that you are leaving the iald.org website. We encourage you to read the privacy statements on the other websites you visit.

About the GDPR

Under the GDPR, the CLD uses the following lawful bases for processing personal data:

- Legitimate Interest As a global lighting design certification, the CLD communicates not only with its members but also with others in allied fields that use or touch on lighting design. The CLD provides information to these individuals about advances in lighting, CLD news, promotion of its members, etc. in order to effectively manage and accomplish the mission of the CLD. Individuals may unsubscribe at any time from receiving this information.
- Consent The CLD will ask explicit permission to collect and process certain
 information such as special categories of personal data. We will always tell you
 directly what information is being requested and what we plan to do with it. We also
 give separate granular options to consent separately to different purposes and types
 of processing. We allow individuals to withdraw their consent at any time without
 detriment.
- Contractual- In order to become a member of the CLD, individuals apply and pay a
 fee which provides basic rights and responsibilities of both the individual and the
 organization. Therefore, there are certain notifications that individuals will receive
 that they cannot opt out of such as certification renewal notices, information about
 governance, elections' information, etc.

People Who Make a Complaint

The CLD strives to meet the highest standards when collecting and using personal information. We take any complaints we receive about this very seriously. We encourage people to bring it to our attention if they think that our collection or use of information is unfair, misleading or inappropriate. We would also welcome any suggestions for improving our procedures.

This privacy notice was drafted with brevity and clarity in mind. It does not provide exhaustive detail of all aspects of the CLD's collection and use of personal information. However, we will provide any additional information or explanation needed. Any requests for this should be sent to one of the addresses below.

If you are a citizen or resident of an EU member state, under the General Data Protection Regulation (GDPR) you may also make a complaint to the supervisory authority of the member state where you reside, where you work, or where an infringement occurred.

If you are a U.K citizen, you can also complain to the ICO if you are unhappy with how we have used your data.
